The Access to Elected Office Wales fund



The **Access to Elected Office Fund** is money to help disabled people stand for **election**.



An **election** is when everyone votes for the person they want to represent them.



The Access to Elected Office Fund can be used to pay for things that help disabled people have an equal chance. For example, special equipment and computers.



Welsh Government started this fund for the **Senedd Cymru election** in **May 2021**.



The fund will now be available for people standing in the Local Government elections in May 2022.



Disability Wales will manage the **Access to Elected Office** Fund. We will:



• tell people about the fund



• give people advice about the fund and how to apply.

Who can apply for the fund?

You can apply if:



you are planning on standing as a
candidate in the 2022 Welsh Local
Government elections. This could be as a
councillor in a city or county council. Or for
your community or town council.

A **candidate** is a person who puts themselves forward and asks people to vote for them in an **election**.



you are disabled



 you are standing in an election for a political party or as an independent.



Some **candidates** are members of **political parties**. For example, Labour party or Green party.



Other **candidates** are **independent** – this means they are not part of a political party.

What you can use the fund for

The fund can be used to pay for things like:



 transport, if you can't use public transport like buses and trains



screen reader software and other computer equipment



 training to use computer equipment and other software



 British Sign Language interpreters, and information in Braille, Easy Read and audio

• personal assistance.

Here are some examples of the types of things this fund can pay for:



Dyfrig is a person with serious sight loss. He finds it hard to walk around when he is out handing out leaflets and talking to people about the **election**.

He can apply for money from the fund to pay for a personal assistant to help him when he's out doing this work.



Bethan is a wheelchair user. She finds it hard to use buses to get around her local area to speak to people and promote herself as a candidate.

She can get money from the fund to pay for taxis.



Habib is a person with dyslexia. He finds it hard to read and answer emails from voters.

He can get money from the fund to pay for a screen reader to help him read his emails.

How to apply



You must check the **Electoral Commission** website <u>www.electoralcommission.org.uk</u> to find out if you are **eligible** to stand in the **election**.



Eligible means you have the right to do something, and can do something, because you meet a list of criteria.

The Electoral Commission

The **Electoral Commission** is the organisation that makes sure **elections** are fair. They check that **candidates** do not spend too much on their **election** campaigns.



If you are **eligible** to stand in the **election** you should contact **Disability Wales**.

How we will make our decision



We will think about what type of support you need, and how much money you need.



We will put this information together in a document.



You will have to tell us if you agree with the document.



We will give the document to the **Decision Making Board**. The document will not say who you are.



People on the **Decision Making Board** will have a different knowledge and experiences.



They will check to make sure you are eligible to apply for this fund.



If we decide to give you money, we will send you:

- an award letter
- a copy of our terms and conditions.



Please sign the terms and conditions and send it back to us.



If we decide not to support you with money from this fund, we will write to you to tell you why.
