Introduction

Disability Wales (DW) is the national association of disabled people's organisations in Wales striving to achieve rights, equality and independent living for all disabled people. Its core role is to reflect the views and priorities of its members to government with the aim of informing and influencing policy.

DW's strategic aims and objectives are:

1. To represent the interests of disabled people in Wales to Welsh Government and other decision makers

- To secure rights, equality and independent living in order to improve the wellbeing of disabled people
- To influence policy and decision makers at all levels, through acting as an effective advocate for the views, priorities and interests of our members

2. To develop and support the work of organisations managed and controlled by disabled people

- To provide information, advice and support to member organisations
- To design and deliver training and development programmes for member groups

3. To lead and develop an effective, sustainable organisation and ensure sound and robust governance

- To lead and manage an effective and efficient organisation for the benefit of disabled people
- To ensure sound and robust governance of the organisation
- To innovate, develop and deliver a range of income generating services that benefit disabled people

Unique Role

DW is the only national pan-impairment organisation representing disabled people and their organisations in Wales. It plays a crucial leadership role in campaigning for disability rights and equality in Wales.

DW has a strong track record and expertise in employing, engaging with and representing disabled people. It is uniquely placed to support Welsh Government and other bodies to achieve best practice in line with duties under the Equality Act (2010) and other legislation, whether as decision makers, employers and/or service providers.

Despite decades of equality legislation and building regulations, DW's experience of searching for new premises illustrates the barriers to employment for so many disabled people, with many workplaces in Wales being inaccessible. It gave validity to much of our policy influencing work over the year regarding tackling the high disability employment gap.

While some issues affecting disabled people are devolved to Welsh Government, UK Government austerity cuts have impacted negatively on many areas of life. Nevertheless through the review of the Framework for Action on Independent Living, DW urged a renewed focus on tackling barriers to disabled people's full participation in Wales

On a positive note a portfolio of photographs was created of each #IAmEmbolden finalist together with case studies of their achievements which are available on DW's website. The images depict the talent as well as outstanding contribution many disabled women are making in the field of arts, sports, education, employment and community life.

Framework for Action on Independent Living Review

DW has continued this role during the Review of the Framework with the Chief Executive chairing the National Stakeholder Steering Group. It actively contributed to a series of engagement activities including four round-table meetings and an online survey to gather the views of disabled people regarding progress in tackling barriers since 2013.

DW in the Media

DW's profile in the mainstream media remained high, with staff and members featuring in more than a dozen stories in news and current affairs programmes, websites and print media.

Four Nations Research

As part of the DRILL Programme, DW worked alongside Inclusion Scotland, Disability Rights UK and Disability Action Northern Ireland to develop a coproduced, qualitative research project examining negative attitudes towards disabled people. As a contribution to this research, the particular focus for DW will be an exploration of the experiences of peer researchers in DRILL funded projects.

Citizen Directed Co-operatives Cymru (CDCC)


