

# Bring Us Our Rights:Disabled People's ManifestoBriefing



# Introduction

Disability Wales is the national association of disabled people's organisations striving to achieve rights and equality of all disabled people.

We at Disability Wales want to ensure that the next five years are spent building a society in which disabled people's rights are realised and upheld. So, in collaboration with disabled people from across Wales, we are proud to present our six asks to political parties in Wales ahead of the Senedd Cymru elections in May 2021.



## **CALL ONE:**

# Implement the United Nations Convention on the Rights of Disabled People (UNCRPD)

The UNCRDP is a disabled people's international human rights agreement that was developed in collaboration with disabled people and their organisations, to provide a framework on how to govern in a way that is inclusive to disabled people and provides a set of principles to be followed – **respect**, **dignity**, **equality** and **freedom**.

Adopting the UNCRDP would mean that the impact on disabled people would be considered for every law and policy developed by Welsh Government and passed through the Senedd. The UNCRDP provides a framework to allow whoever implements it to understand the action that needs to be taken and the standards that should be met. Implementation of this Convention would enable a significant change. By implementing the UNCRDP, all of the five other asks and many of the issues raised by disabled people that could not fit into this manifesto would be addressed.

- Implement the UNCRDP into Welsh Law
- Support local authorities to enforce actions resulting from its implementation
- Explore establishing a Disabled People's Commissioner to further ensure enforcement
- Support the establishment of a disabled people's organisation in every local authority in Wales and build on the DPO emergency funding to develop the capacity of DPOs across Wales.

# CALL TWO: Awareness

A major concern from disabled people we spoke to was the **lack of awareness** of issues related to disabled people. Awareness is covered as a key area in Article 8 of the UNCRDP, calling on those who adopt it to raise awareness and combat stereotypes affecting disabled people. It also sets out measures to show how this can be done.

- Programmes that raise public awareness of disability rights issues and the concerns of disabled people including in the school curriculum, professional training schemes and employer initiatives
- Ensuring that the Minister with responsibility for Equalities gives regular media briefings on progress with tackling inequality including in relation to disabled people
- Encourage disabled people to participate in political life by signing up to the Access to Elected Office Fund.





# CALL THREE: Social care and independent living

Many disabled people we spoke told us that they have experienced issues with their **ability to live independently**. We have been told that disabled people in Wales have great difficulty in accessing social care and that this has a major impact on their ability to achieve independent living. Independent Living enables us as disabled people to **achieve our own goals and live our own lives** in the way that we choose for ourselves.

Article 19 of the UNCRDP would commit Wales to ensuring that policy, legislation and service delivery facilitate independent living.


#### We call for:

- Commitment to ensuring that the Framework for Action on Disability: the Right to Independent Living is regularly reviewed, updated and implemented in co-production with disabled people and Disabled People's Organisations.
- Commit to supporting Local Authorities to develop and deliver services in coproduction with disabled people and disabled people's organisations which fulfil the right to independent living.

# CALL FOUR: Health

Many disabled people we spoke to told us about **issues that they have faced in the health system**. Welsh healthcare that it needs to be more patient-driven and work better with disabled people. Article 25 of the UNCRDP would commit Wales to a truly accessible health service.

- Ensuring disability equality training is mandatory for regional partnership boards, local health boards, healthcare staff and addresses intersectionality including issues affecting disabled women, BAME disabled people and LGBT+ disabled people
- Work coproductively with citizen representatives and service users, especially those for whom English or Welsh is not their first language, to ensure person directed planning.



# **CALL FIVE:**Jobs

**Employment** has been a major concern for many disabled people who we spoke to. Article 27 of the UNCRDP recognises the rights of disabled people to work and enjoy a job market that is open and accessible to them. By implementing the UNCRDP and these asks, we can work towards a Wales which provides opportunities for its disabled workforce.

- Welsh Government providing a beacon of best practice as an employer of disabled people
- Make Disability Equality Training mandatory at all levels of Government and public bodies
- Ensure the economic contract with employers and business in Wales incorporates enforceable measures to tackle the disability employment gap
- Protect the rights of disabled people in the workplace through ensuring access to discrimination advice services
- Working in co-production with disabled people and their organisations, create bench-marks to demonstrate good practise for employers.

# CALL SIX: Housing

Access to quality, suitable housing was also a key issue that arose from our research. Should the UNCRDP be adopted into Welsh law, article 28 would provide guidance for creating housing that is suitable for all and begin the work towards a Wales where no one has to worry about accessing appropriate housing.

- Accessibility standards for social housing in Wales, to be developed in co-production with disabled people and their organisations.
- Ensure that local authorities and property developers comply with these standards
- To provide Disability Equality Training to support staff including working with non-verbal disabled people and alternative methods of communication
- To review the age requirement regarding social housing allocations.

## Conclusion

We see a desire for the voices of disabled people to be heard in the Senedd, from both disabled people and politicians themselves.

By implementing the UNCRDP and our asks, we can work towards a future Wales where everyone, regardless of impairment, has full access to the world around them, can engage with their community and does not need to worry about the quality of their services. We believe that this future is possible, these are the building blocks that must be cemented in order to get there.
